President's Award	To be considered for nomination a member should be or have been an active member of CAPLA for a minimum of ten years and shall have made outstanding volunteer contributions of a diverse nature in the building of the association over a sustained period.
Outstanding Volunteer Award	To be considered for nomination a member should be or have been an active member of CAPLA for more than five years and shall have made outstanding volunteer contributions towards the success of the association while in various roles and positions within CAPLA.
Rising Star Award	To be considered for nomination a member should be or have been an active member of CAPLA for five years or less and shall have made outstanding volunteer contributions in building the future of the association with innovative ideas, energy and enthusiasm, and delivering results and sustained value to CAPLA by working effectively with others.
T. Cathy Miller Champion Award	Awarded to corporations who have supported CAPLA through partnerships, sponsorships, and encouraging their employees to become involved in CAPLA initiatives.
Committee of the Year Award	One CAPLA committee will be recognized for its success in meeting and exceeding expectations, and for providing outcomes that are of direct benefit to the CAPLA membership.
Myra Drumm Memorial Student Achievement Award	Awarded to an outstanding land administration student graduating from either the SAIT, MRU, Olds College, or CEAMS programs.
Honourary Lifetime Member Appointment	Awarded to individuals who have made longstanding contributions resulting in significant benefits to CAPLA's vision, mission, members, or profile in the energy industry.
